Shareholders of the Company, holding shares either in physical or in dematerialised form, as on 14th September 2018, i.e. the cut-off date, may cast their vote electronically when the remote e-voting is kept open.

Please read the instructions printed overleaf before exercising the vote. This communication is an integral part of the Notice dated 11th July, 2018 for convening the 59th Annual General Meeting of the Company. A copy of the said Notice is enclosed.

INSTRUCTIONS FOR REMOTE E-VOTING

The process and manner for remote e-voting are as under:

- In case a Member receives an email from Karvy [for members whose email IDs are registered with the Company/Depository Participant(s)]:
 - Launch internet browser by typing the URL: https://evoting.karvy.com
 - Enter the login credentials i.e. (User ID and password mentioned above). Your Folio No. /DP. ID -Client ID will be your User ID. However ii. if you are already registered with Karvy for e-voting, you can use your existing User ID and Password for casting your vote.
 - iii. After entering the above details Click on - Login.
 - Password change menu will appear. Change the password with new password of your choice. The new password shall comprise minimum 8 characters with at least one upper case (A-Z), one lower case (a-z), one numeric (0-9) and a special character (@,#,\$, etc). The System will also prompt you to update your contact details like mobile number, email ID, etc. on first login. You may also enter a secret question and answer of your choice to retrieve your password, in case if you forget it. It is strongly recommended not to share your password with any person and take utmost care to keep it confidential. After changing the password, you need to login again with the new credentials.
 - On successful login, the system will prompt you to select the E-Voting Event i.e "Hindalco Industries Limited". V.
 - On the voting page, enter the number of shares (which represents the number of votes) as on the Cut off date under "FOR/AGAINST" or alternatively, you may partially enter any number in "FOR"and partially in "AGAINST" but the total number in "FOR/AGAINST" taken together should not exceed your total shares held as of the cut-off date. You may also choose to ABSTAIN from voting. If the shareholder doesn't indicate either "FOR/AGAINST" it will be treated as "ABSTAIN" and the shares held will not be counted under either
 - vii. Shareholders holding multiple Folios/Demat Accounts shall choose the voting process separately for each Folios/Demat Accounts.
 - Voting has to be done for each item of the Notice separately.
 - You may then cast your vote by selecting an appropriate option and click on "SUBMIT".
 - A Confirmation Box will be displayed. Click "OK" to confirm else "CANCEL" to modify. Once you confirm, you will not be allowed to х. modify your vote.
 - Corporate/Institutional shareholders (i.e. other than Individuals, HUF, NRI etc.) are required to send scanned certified true copy (PDF/JPG xi. Format) of the relevant Board Resolution/Authority Letter alongwith attested specimen signatures of the duly authorised signatory(ies) who are authorised to vote, to the Company at E-mail ID: hilinvestors@adityabirla.com with a copy marked to evoting@karvy.com The scanned image of the above mentioned documents should be in the naming format "Corporate name_ EVENT NO."
- In case a Member receives physical copy of the Notice of AGM [for members whose E-mail IDs are not registered with the Company/ Depository Participant(s) or requesting physical copy]:

C. OTHER INSTRUCTIONS

- The voting rights of members shall be in proportion to their shares to the paid up equity share capital of the Company as on the cut-off date i.e. Friday, 14th September, 2018.
- A person, whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as II. on the cut-off date only shall be entitled to avail the facility of remote e-voting as well as voting at the AGM through electronic voting.
- Any person, who acquires shares of the Company and becomes member of the Company after dispatch of the notice and holding shares as III. on the cut-off date i.e. Friday, 14th September, 2018, may obtain the Login ID and Password by sending a request at evoting@karvy.com

- Mr. B. Narasimhan, proprietor of BN & Associates (Membership No. FCS 1303 and COP No:10440) has been appointed as the V. Scrutinizer for providing facility to the members of the Company to scrutinize the voting and remote e-voting process in a fair and transparent manner.
- VI. The Chairman of the meeting shall, at the AGM at the end of discussion on the resolutions on which voting is to be held, allow voting with the assistance of scrutinizer, by use of "electronic voting devices" for all those members who are present at the AGM but have not cast their votes by availing the remote e-voting facility.
- The Scrutinizer shall after the conclusion of voting at the AGM, first count the votes cast at the meeting and thereafter unblock the votes cast through remote e-voting in the presence of at least two witnesses not in the employment of the Company and shall make, not later than three days of the conclusion of the AGM, a consolidated scrutinizer's report of the total votes cast in favour or against, if any, to the Chairman or a person authorised by him in writing, who shall countersign the same and declare the result of the voting within 48 hours of the AGM.
- VIII. The Results declared along with the report of the Scrutinizer shall be placed on the website of the Company www.hindalco.com and on the website of Karvy www.evoting.karvy.com immediately after the declaration of result by the Chairman or any other person authorised by him in writing. The results shall also be immediately forwarded to the Stock Exchanges viz BSE Limited and National Stock Exchange of India Limited, Mumbai.
