(i)	The project proponent shall submit compliance status of the action plan formulated by the State Pollution Control Board and required to be undertaken by them for their captive power and other plants in the area within one month. (ii)	In case source of fuel supply is to be changed at a later stage (now proposed imported coal from Indonesia / South Africa) the project proponent shall intimate the Ministry well in advance along with necessary requisite documents for its concurrence for allowing the change. In such a case the necessary for reconducting public hearing may be decided by the Ministry in consultation with the Expert Appraisal Committee.
